Response Rate 18/27 (66.67%)

- Due to the lecture style of the course, I found it hard to stay engaged in classes.

- I felt very engaged in the class and the material presented. I tried to always do the readings, and took notes during every class. I wish I took more advantage of office hours, but overall felt like I had a successful course.
- I would say I came to class pretty engaged and got the valuable help I needed from my instructor, peers, and sources assigned.
- I was highly engaged in this course. Although the lecture was largely a lecture based format, the professor still provided many opportunities for questions, even providing a section at the end of every lecture block for questions. As a student who asks a lot of questions, professor Hale made sure to answer my questions will still answering other peoples questions, which I appreciated.
- I was engaged with the readings of this class and found they built upon each other well, with main ideas such as party polarization and gaps between demographic groups being maintained throughout as core subject matter.
- Generally pretty engaged, most of the readings that we were assigned for the class were generally pretty short and engaging, and the professor did a good job of varying the styles of writing, so that we weren't always reading long journal articles or academic papers, which definitely helped motivate me to actually do them. Additionally, the professor did a very good job of making lectures conversational, in that he constantly entertained questions and did not shy away from an impromptu debate about any relevant topic. He also did a good job of incorporating current events into the class, which made topics all the more entertaining. Lectures were also just funny, and the professor did a good job of incorporating jokes and lightening the mood of what could be a fairly dark and depressing topic at times.
- I would say my level of engagement in this course was pretty high. I did most of the readings, went to office hours a few times. I thought it was pretty easy to stay on top of the work.
- I felt super engaged in this class, and I felt that I was constantly intrigued and interested in the class, I always made sure to bring supplies for note-taking, and always tried to ask at least one question or make a contributing comment per class.

Towards the end of the class, I (and it felt like other students as well) stopped doing all of the readings but it didn't feel like I behind at all.
- I made an effort to participate in class when I could and answer questions. I sought help from peers when I was confused about assignments or concepts, or when I missed class and needed notes.

- I don't think I gained many skills for this course, it was mostly just note taking and lectures. I got a little better at understanding graphs.
- I hoped to broaden and solidify my understanding of politics in America and my role within them, and I feel as though I gained this from the course.
- i learned specific terminology and historical precident that helped to crystalize my understanding of politics into specific words.
- The response papers were helpful in my writing in terms of clarity. Having a sentence limit aided in the directness of my answers and forced me to omit any fluff or unnecessary ideas. I expected to gain background in politics and did so, but I am glad this class helped with my writing too.
- I expected to learn how to think politically and gain better practice writing and both of those were developed during the span of this course
- I didn't expect to gain any skills from this course. What skill the course did teach me though is how to better process information and how to note take. We often moved the material at a reasonable pace so I had to figure out what to jot down and how to interpret the information in a way I understand.
- I expected to gain a basic understanding of government branches, which I did. Still, the course expanded upon that by teaching me about the intricacies of campaigning and political messaging. It inspired me to engage in less common forms of political action, such as donating to campaigns.
- I expected to learn a bit more about our government and how to better participate in American Democracy, and I feel like I did learn information about a few ways that I can better participate and take advantage of my position as an American citizen (most importantly that you can register to vote in the state that you attend college). However, the course was relatively light in terms of writing, which, in some ways, helped me, as I felt that I could better absorb the material rather than focusing on what would make a good essay, but also didn't really help improve my overall writing skills, which I was kind of hoping for.
- I think this class does a great job in helping you learn to build your ideas off of other ideas that you have learned in the past.
- I expected to gain at least a basic understanding of politics at a national and sometimes state level, and in reality, we dug much deeper than I believed we were going to, and I learned a lot about the intricacies of not just Congress and the house, but also statistical methods of electoral prediction mapping, state and national laws and their exceptions, and much more.
- I really had no idea what polysi really was, it always sounded like one of those made up college terms, a bit ignorant of me for sure. This course has allowed me to develop skills that let me understand underly9ing factos of our political system and just the sheer basics of how it works. - The lectures were both exciting and interesting, with the videos and graphs being effective in supporting the content.
- I thought the class was structured well, the structure was fairly straightforward. All of the weekly assignments lined up well with the readings and lectures.
- . The lecture heavy classes did hinder my ability to focus in all classes
- The professor gave out readings that extended what we learned in class, though sometimes they were unnecessarily long for unrevolutionary subject matter. The professor's assignments were always helpful in demonstrating understanding of the subject matter
- I think the lectures were always engaging. Professor Hale teaches in a way that is energetic and passionate so you know he cares for the subject matter. Taking notes in class were the most effective way for me to retain material and was encouraged by Professor Hale. As I said previously too, the response papers were a great way to understand material through thought-provoking questions.
- I feel like the discussion aspect of the class really helped me and the structure of the class with its lectures and various strategies, one aspect that might have been challenging was some of the assigned readings were a bit tough to comprehend at the time of doing them, but usually the following class would help understand more of the reading, one aspect I wish there was more of was group projects and collaboration
- I didn't think there was anything in Hales instruction that was particularly ineffective. What I thought was especially effective was the consistent use of real world references when discussing certain concepts, like lobbying. Its important to ground the material, and Professor Hale did a good job of this.
- Every week we had a written assignment engaging with questions that pertained to that week's course material, which I found to be a helpful checkpoint that made sure I was on the right track and was grasping weekly key concepts.
- I enjoyed most of the readings, I thought that they were generally pretty varied in style, and generally not overly academic, which I think motivated me to actually read them. I also thought that the lectures were generally engaging, as the professor encouraged debate and constantly stopped for questions.
- I thought class periods were structured well though we could get a little bit off track occasionally. I thought the group work was fairly limited, but because this is a lecture class I think that is ok. I appreciate that we didn't have any quizzes because it would be giving quizzes just to give them. The reading was mostly helpful but sometimes a little hard to follow.
- Although I was never particularly keen on teaching through lectures, Professor Hale spent a lot of time creating engaging, interesting, and easy-to-follow lecture slides that were current and up-to-date with the ever-changing political landscape in our country. I also thought that the weekly response papers based on the week's lectures and unit were a good way to help me understand the topic at hand and answer questions based on the topic.
- Your response paper setup was super effective, it insured i was completely on the same page with each week of work and didnt let me fall behind. Your strcit deadline was very reasonable, but the strictness of it kept me on track. Something i greatly appreciated.
- The professor tied everything back to current real-world examples, which was most effective for me. The structure flowed well, with every topic leading into the next, crescending with an examination of everything we learned and how current political structure is proposed at being reformed, and finally looking at and voting on which reforms the class body supported.
- I thought the lectures were very clear, interesting, and engaging. The response papers challenged me to think about what we learned that week and to put concepts in my own words, yet it was not an overwhelming amount of work to do every week.
- I found Professor Hale's lectures very engaging. I think he is excellent at spacing out text with graphs and modern day examples and engages the students in the class well with questions interspersed throughout the lecture. I also liked the weekly response papers which ensured my understanding of the readings and topics. I think there could have been a few more in class exercises/group work. but I don't think the lack of such impeded my learning. I enjoyed the day that we worked on the spatial model worksheet with classmates though.
- The weekly reading responses helped my learning because it was a good way for me to be able to revisit important concepts from the week and deepen my learning
- i am a huge fan of the weekly response papers. I think they were very manageable and I did learn a lot from them, they helped me with figuring out what I was still confused about, etc.

- The questions asked during the lecture by Professor Hale gave us the opportunity to respond critically
- I thought that the lectures were very entertaining and engaging. This incentivized me to learn more and pay more attention.
- professor always took questions and answers with grace and professionalism, leading students to want to engage in class material. Remained politically neutral and fostered the creation of new ideas regarding political topics rather than enforcing preexisting opinions, which is especially important in an introductory politics class i feel.
- Professor Hale always tried to call on students an equal amount. As a student who did not always raise my hand or participate, whenever I did, Professor Hale would always make an effort to call on me. I think we could have done more group work to be more comfortable with the other classmates and get to know people around us.
- I feel like the most influential aspect of the class was the size of the class because it provided more opinions on topics we learned about and discussed
- Nothing really hindered a inclusive learning environment. I do appreciate that professor Hale made us all make name tags at the beginning of the semester to make sure no one ever had their name forgotten or mispronounced. It shows that professor Hale really cares about his students.
- The professor was very encouraging throughout the semester and repeated to us how we all had valuable things to contribute and that the space was open for us, especially if we did not often speak, which I find much more inviting than a cold-calling situation.
- Just as a product of the Oxy community overall, the perspectives in the class were generally fairly left-leaning, which makes political debates somewhat dry, as everyone has generally the same opinion. It also means that people who had potentially conflicting opinions did not necessarily want to share them for fear of being immediately shut down. This is not the professor's fault by any means, this happens in every Oxy class that I have taken, but it might be a little exacerbated in a politics class where talking about policies and opposing parties made up much of the coursework.
- Hale let us offer our own opinions often
- The one thing I wished we had a little more of was group work rather than the whole class dedicated to lecture, that way it would allow us to put our understanding off the subject to use in class in real project/activity scenarios, and we could learn from each other as peers.
- Using memes, not pressuring people to speak but also encouraging, removing stigma from getting the wrong answer.
- Unfortunately it felt like many of the students who participated in class discussions were the same couple of people each time, maybe hindering people who aren't as comfortable at speaking from participating.
- This class was a comfortable environment to participate in and having the name tags made me feel more seen instead of just being an anonymous student.
- I think this class was well structured to hear all voices. Professor Hale made an effort to call on participants who did not participate often to create a well-balanced classroom with various voices and opinions. I also appreciate how he always made himself available for questions via email and office hours and I felt very supported by him throughout the course. I think others would have felt this way as well.
