I also attended office hours whenever I did not understand a specific topic within the lesson. • Very good • I was really engaged with the class material and discussions, I talked when I felt like I had something to share. • Within class, I would describe myself as highly engaged, although marginally underprepared. The material and in-class questions sometimes felt marginally condescending, but that is only natural in a 101 course, as people come in with all different levels of background. • Yes, it was easy to be prepared for this class which is nice because you can still learn good content. I sought help from my peers when needing missed notes. • I participated thoroughly throughout the course, trying to participate everyday. I also did all the readings and studied well for our quizzes. • I would say that I was fairly engaged throughout the course; through the medium of answering questions in class and electing to orate important quotes for the class that were provided in the slides. • I always came to class prepared and ready to learn. I listened and took thorough notes during every class. I reached out for support to my professor earlier in the semester when needed. • I would come to class having done most readings, and was actively engaged during the class. • I always came to class prepared; however, toward the end of the semester, it became harder and harder to prepare. I felt the workload/readings increased as the semester went on, which was the opposite of a lot of my other courses. I definitely attended office hours, but I wish I had utilized them more. There wasn't really a lot of camaraderie among classmates, so I felt like I couldn't reach out for help. Actually, once I reached out to a classmate for help, and was left on read. • I didn't contribute too much in class but I also didn't need to seek too much help. • I did the assigned readings before class and took notes on the important details in order to come to class prepared, participated during lectures and discussions, took notes on in class lectures. reviewed published slides as needed and worked with my peers when needed. • My level of engagement in this course would be ranked as high because I made sure to come prepared to class by reviewing the readings and checking in with my professor whenever I was confused on a concept. 2 - 2. How did this course influence, change, or help shape your understanding of the subject matter?

We were challenged to critique the literal systems in which we live and exist, and discuss possible reforms that seem radical but truly would likely be better options. • I expected to gain critical thinking about politics in addition to basic facts. I think critical thinking was to a somewhat limited extent, and the theories helped with that, but it makes a lot of sense that we have to cover basic government functions before going deeper, so we know what we're doing. I do feel more confident about government procedures and how they relate to the Madisonian design, which I didn't know before. • I gained and enhanced my critical thinking skills, communication skills, and note taking skills throughout this course. Through practicing these skills in class and while preparing for class, I was able to set myself up for success. • I gained the skills of critical thinking and also being analytical because for most of the big concepts that were covered in this class, I was able to get a better understanding whenever there was a graph to analyze. The course also challenged me to think beyond just the concepts and to connect it to previous ones to form my own arguments. • I gained close reading skills that helped me really understand the articles we were given and apply them to real world examples. I also got better at engaging in class discussions and formulating my thoughts on a particular subject matter quickly so that I could participate. I also gained the skill of interpreting graphs better, and professor hale used a variety of political graphs throughout his slides. • I feel like this course got me a great understanding of the reading schedule for a college political science course. It was the perfect amount of engaging readings and lectures that I felt like I really got a great introduction to the politics department here at Oxy. Overall, the course definitely expanded my reading stamina for various different types of political readings. • I expected for this course to be similar to my AP government course I took in high school, but more in-depth and comprehensive. Every lesson was broken down by week and it all was contributing to what would be taught the following week. • The lectures were very engaging, Professor Hale is a very good lecturer • Nothing prevented me from learning well, this class was really insightful • Readings dragged as they all do, so that is difficult to fix. Lectures were engaging but sometimes simple to an extent that they lost that engagement. • Readings were somewhat ineffective because we talked about it in class, but the lectures were very helpful. • I think the lectures throughout the semester were quite effective. It deeply helped me understand how the American political system worked. Professor Hale did a good job of allowing us to participate, and I think the class engagement truly did help. Nothing necessarily was ineffective nor impeded my learning. • Effective: The quiz structure was amazing in terms of preparation for the final with the graded aspect forcing you to truly retain the information if done properly. The accessibility of the course materials was also extremely helpful if/when a student has to miss class. • I really liked how classes were taught through lectures. Could have showed up without having done and winged it. • I think that the readings and quizzes were really effective in helping us learn the content; however, in terms of really internalizing it, I'm not sure if lectures really helped. For me, I really prefer discussion and in-class exercises, but I imagine that would be difficult to do with a 101 Pols class. I think in some ways it can definitely be integrated. It's one thing for a student to be able to say how something operates, but being able to articulate a critical analysis of it is another. • I liked the lectures a lot, especially the fun videos that are good real-world examples of the more stuffy stuff we learn (watching a video of a filibuster instead of solely defining it and moving on), so I appreciated that. I would've enjoyed a little bit more of small group discussion or handouts to work on together. That way, it's a little bit less intimidating to share an answer and we can talk out solutions. I liked how we did that for a difficult topic like the voting scale thing (blanking on the term) • The professor's lectures were entertaining and informative. I was able to learn a lot while being in a respectful, open, yet humorous environment, which made coming to class and participating very enjoyable. Few readings were long which made them harder to complete with a full course-load of other reading heavy classes, but work was still very manageable. • The aspects of the instruction that were particularly effective were the lecture slides since it was a useful tool to look back whenever I was reviewing before a quiz. I also think that the quizzes were effective for what they usually asked in the written responses, however there were some questions that I believed were too vague and not as specific. • I really appreciated the lectures professor hale gave. They always connected well to the readings we did the night prior, and included meaningful graphs and real world examples that helped us connect tougher topics to more understandable graphics. I also really appreciated the readings we did, especially the more contemporary ones that included connections to modern politics or issues. • The lectures were very effective in helping me and the peers in my class understand some things that may not have been as clear in the readings. Our Professor did an amazing job engaging the class in a wide range of subjects in American Politics that were completely new to many of us. I loved the quiz structure of the class as well because it provided a benchmark for our learning in the class for each week and forced us to remember everything that was taught. • The lectures at times, were a little too fast paced, and discussions were frequent enough. - The course created an inclusive environment whenever participation was encouraged which was all the time. This made sure that a diverse group of students were partaking in the class discussions which promotes success.
- Professor hale created an extremely inclusive environment, where I never felt scared to raise my hand and say something wrong. I would think this was the overall consensus of the class as well, as we frequently engaged in class-wide participation/ discussion. Also, professor hale had flexible and helpful office hours which helped students struggling with a particular topic feel more at ease. I also really appreciated the structure of the quiz system (worst 2 get dropped).
- The class was structured in a way that was extremely helpful to students who did the readings and wanted to know more. Our professor did an amazing job ironing out some confusions that we had in the readings. The class structure itself was very clean and had consistent readings and quizzes to really have an organized schedule.
