2 - 2. How did this course influence, change, or help shape your understanding of the subject matter?

• I wasn't really familiar with the concept of comparative politics before this course, nor was I that familiar with the intricacies of certain systems and the ways in which some countries run those systems. Overall, I felt that this was arguably the class I learned the most from.

· It opened my mind to comparing politics of other countries and appropriate ways to do it.

Institutional dynamics that I had not fully considered or understood Semi-presidential systems, and the difference between premier-presidential and president-parliamentary systems Gaining a more
systematic/empirical view of revolutions and coups Justifiable revolutions can fail for material reasons, and unjust coups can also succeed for material reasons. Analyzing coups and revolutions by the
groups supporting, institutional powers, and the ability of the coup/revolution to control the media. Also understanding the methodology of comparative politics, and how to apply it as a science, rather
than as a purely descriptive field.

This helped me see governance better and it opened up my eyes to poli. sci.

· Slides were helpful but sometimes repetitive. Readings were interesting

· I enjoyed the lectures thoroughly and believe that the response papers were a great way to build in understanding after classes.

• I felt that the presentation was engaging. The professor was clearly passionate about the subject and made learning about topics such as parliamentarianism shockingly fun. I think that, without his presentation, the class would have been far less interesting and engaging.

• For me, some of the small group discussions were helpful in discussing class material. I wish that sometimes the classes were less lecture based and more discussion based.

• I think the lecture based classes are really effective because his presentations are easy to follow.

• The response papers were effective, as were the lectures. In retrospect, some of the focus on US politics felt detached from the concepts. The focus on world politics was important, especially on governments with different systems(such as pure parliamentary, semi presidential, full presidential), as it applied the concepts to a real situation.

• I liked discussions and group work. He did a good job of having readings on par with course material!

• I enjoy Professor Hale's lecture style. He is very knowledgeable at answering student questions and keeps the class as engaged as possible. He is very friendly. A few students were very keen to participate in lectures, and Professor Hale seemingly did what he could to ensure that everyone in class felt like they could participate as much as they would like.

• The class structure was the same practically every time. This was boring at times, but I know it would of been difficult to tailor the class any other way. I enjoy the videos in class in the slidedeck because it is different than just the slides with just words. The class simply was the professor speaking to the class and at the end, asking if there were any questions. At times, I also felt that if I missed class, I would not be behind. The slides had everything I needed to answer the weekly responses.

· I thought the lectures were very engaging. I also thought the case studies were a fun way to apply the theory.

• I think that the country cases were extremely helpful to understanding comparative politics, as it allowed insight into how different political systems work in different areas of the world, and how that changes outcomes. I think that if there were slightly more in class activities (which I acknowledge is difficult with this subject matter) would be helpful to keep the content of the class engaging for the whole class.

• Weekly response papers were extremely helpful in keeping me on top of the reading and paying attention in each class. I also appreciated the different types of reading and how they showed several perspectives. I also enjoy Professor Hale's teaching style as he engages the class by asking many questions, providing both lectures and videos to keep our focus, and adds funny anecdotes into his lectures to make the course fun. I also REALLY appreciate the no technology rule as it is much easier to engage without my own laptop in front of me and I am not distracted by others on their electronics.

• I believe some of the readings were a bit challenging. I found it helpful when a few sidles were dedicated to the reading to help me better understand the author(s)' main argument/ message. It was also helpful when the slides were posted before class which helped with my notes during class. Overall, I though the lectures and discussions were very engaging and made the course content very digestible. The use of many examples was also helpful in understanding the course topics.

• I thought the course was extremely effective in explaining the comparative political landscape of today. The setup of the course provided an opportunity to complete the readings understand the concepts then discuss these concepts in our class discussions and lectures. The lectures provided a deep understanding of the concepts and varying types of politics.

5 - 5. What aspects of the course or instruction helped or hindered the creation of an inclusive learning environment that is responsive to, and promotes the success of, a diverse group of students?

• The professor was good about trying to encourage new voices to speak up when asking questions and presenting scenarios. He was also good about answering questions and not coming across as condecending.

· Literally nothing hindered it.

· Calling on people that did not ask questions as frequently was important.

· He tried to include everyone and get "new voices" when people weren't volunteering themselves.

• The structure of the class was fairly inclusive and was well thought out. Having the slides available post class was useful to students who were unable to make the lecture. I also liked the focused questions of the weekly assignments, as they almost exclusively asked questions relevant to that weeks material, while occasionally incorporating big ideas and systems we have learned throughout the semester.

• The class was very inclusive of a learning environment. Everyone had an equal opportunity to discuss what they thought in the class and the professor always allowed for questions and for people to speak out.

• I thought the learning environment was inclusive for a diverse group of students.

• The lecture structure of the class certainly helped massively to understand the overall subject of comparative politics and is absolutely necessary, however if there were a few more classes that involved actives or more class engagement, I think that the subject matter would have become even more interesting and engaging.

• Professor Hale included case studies and examples of the topics we learned from all around the world, showing how these ideas can be used to analyze any country for better understanding.

• I think the course structure helped guide students to success. For instance, the response write-ups were a way to engage with course content and makes sure you understand the big picture.

The lecture-style course provided opportunities to ask clarifying questions and add points that people might have a direct opinion or connection to.

• I think a lack of group work made it difficult to feel comfortable participating at times.

• Professor Hale is really good at responding to students and creates a really welcoming learning environment for students. He did this despite some challenging students who didn't necessarily raise their hands before they spoke.
